AEO-F status is a quality mark awarded to companies based on their reliability, safety, and security in the international trade of goods. Thanks to reduced checks and preferential customs treatment, the world customs certificate speeds up customs clearance for both imports and exports. To be approved as an AEO-F involves meeting a wide range of requirements. As part of the certification process for INNIO in Jenbach, checks included an examination of the company's financial solvency, compliance measures, sound accounting methods, and observance of customs legislation, as well as its management of safety, security, and quality matters.

“AEO-F certification is an important initiative for a thoroughly secure international supply chain – from the upstream supplier through the manufacturer to the end consumer. AEO-F status is recognized around the world by members of the European Union, Switzerland, the U.S., Norway, Japan, Andorra, and China. The AEO-F certificate combines the customs simplification of AEO-C (customs) and the safety and security elements of AEO-S (safety and security) and represents the highest achievable level of customs certification. Security for the movement of goods within international trade is becoming increasingly vital due to continuing globalization and growing international terrorism.
